GENERAL INFORMATION AND TERMS OF BUSINESS

- 1. TOUR PRICE:** Total tour fare in double room and cabin is \$3,254 per person. Single room supplement only for the hotel rooms is \$354 per person in the entire tour program. Single room supplement for both the hotel rooms and yacht cabin is \$1244 per person in the entire tour program. All prices are quoted in U.S. dollars and must be paid in U.S. dollars. In order to keep rates as low as possible, we do not build into the tour fare an allowance to cover possible increases from currency fluctuations or fuel costs. Therefore, as currencies do fluctuate around the world and fuel-cost increases may occur, it may be necessary for us to initiate a minor rate surcharge at any time before departure if there are exceptional cost increases beyond our control.
- 2. RESERVATION AND PAYMENT:** The deposit of \$300 per person, along with a completed and signed Reservation Form, will reserve a place for you in this Argeus Tourism & Travel program. The balance of the tour fare is due 60 days prior to departure, on March 01, 2008. Credit cards are accepted for deposits only.
- 3. CANCELLATION and REFUND POLICY: Notification of cancellation must be submitted to our office in writing and received by Argeus Tourism & Travel.** Argeus Tourism & Travel is not responsible for any delay during the mailing process. At the time we receive your written cancellation, the following penalties will apply:
 - 61 days or more prior to the tour departure: \$300 per person
 - 46 through 60 days prior to the tour departure: 25% of the total tour fare
 - 31 through 45 days prior to the tour departure: 50% of the total tour fare
 - 1 through 30 days prior to the tour departure: 100% of the total tour fareSome air fare may be nonrefundable. Once the tour has departed, there will be no refunds from Argeus Tourism & Travel for any unused portions of the tour program. The above policy also applies to all extensions and independent travel arrangements made in conjunctions with this tour program.
- 4. TRIP CANCELLATION AND INTERRUPTION INSURANCE:** We strongly recommend that all travelers purchase trip cancellation and interruption insurance as protection against an emergency that may force you to cancel or leave the tour while it is in progress. Argeus Tourism & Travel will not be held responsible for any expenses or losses incurred resulting from the buyer's cancellation of this trip. You may purchase your cancellation and interruption insurance from www.travelguard.com or www.travelex-insurance.com. Argeus Tourism & Travel will not be held responsible for any losses that would be covered by the purchase of travel insurance.
- 5. SHARE POLICY:** Accommodations on all Argeus Tourism & Travel programs are based on double occupancy. If you are traveling alone and wish to share accommodations, a roommate will be assigned to you whenever possible. When pairing roommates, we always pair participants of the same sex. All shared accommodations are nonsmoking. If it is not possible to pair you with a roommate, you will be asked to pay a single supplement for the land and sea portion of the program.
- 6. PARTICIPATION:** Argeus Tourism & Travel reserves the right to decline to accept any individual as a tour member for any reason whatsoever.
- 7. AIRLINE RESPONSIBILITY CLAUSE** -The carriers concerned are not to be held responsible for any act, omission, or event during the time the passengers are not aboard the aircraft or conveyance. The passenger ticket shall constitute the sole contract between the airline and the passenger. Air schedules are subject to change and airfares are quoted as of August 19, 2007 and are subject to increase.
- 8. MEDICAL INFORMATION:** Participation in an Argeus Tourism & Travel program requires that you be in generally good health. It is essential that guests with any medical problems and related dietary restrictions make them known to us well before departure. We can counsel you on whether the tour program you have selected is appropriate for you. The tour leader has the right to disqualify any participant at any time during the tour program if he or she feels the participant is physically incapable and/or if a participant's continued participation will jeopardize either the individual involved or the group. There will be no refund given under these circumstances.

- 9. ITINERARY CHANGE and TRIP DELAY:** Itineraries are based on information available at the time planning and printing and are subject to change. Argeus Tourism & Travel reserves the right to change a tour program's dates, staff, itineraries, or accommodations as conditions warrant. If a trip must be delayed or the itinerary changed due to bad weather, road conditions, transportation delays, government interventions, airlines schedules, sickness, or other contingency for which Argeus Tourism & Travel or its outfitters can not make provision, the cost of delays or changes is not included.
- 10. TOUR PROGRAM CANCELLATION:** Argeus Tourism & Travel reserves the right to cancel a tour program for any reason whatsoever, including too few participants or logistical problems such as strikes, civil uprisings, wars and other military actions, acts of God, or any other circumstances that might make operation of the tour program inadvisable in either the country of origin or destination to travel. All payments received will be refunded in accordance with Cancellation and Refund Policy in item 3 above, and this refund will be the limit of Argeus Tourism & Travel's liability. Argeus is not responsible for any expenses incurred by tour participants in preparing for the tour program, including nonrefundable or penalty-carrying airline tickets, visa or passport fees, or other tour-related expenses.
- 11. RESPONSIBILITY and LIMITATIONS OF LIABILITY:** Argeus Tourism & Travel, its Owners, Employees act only as the agents for the owners, contractors, and suppliers providing means of transportation and/or all other related travel services and assume no responsibility howsoever caused for injury, loss, or damage to person or property in connection with any service resulting directly from: acts of God, government restrictions or regulations, civil disturbances, strikes, terrorism, military actions or wars, detention, annoyance, delays, expenses arising from quarantine, thefts, pilferage, failure of any means of conveyance to arrive and depart as scheduled, and discrepancies or changes in transit or hotel services over which it has no control. Reasonable changes in the tour program may be made where deemed advisable for the comfort and well-being of the passengers.
- 12. DISCLOSURE:** Please be aware that during your participation in a tour certain risks and dangers may arise, including, but not limited to, the hazards of traveling in undeveloped areas, travel by boat, train, automobile, aircraft or other means of conveyance, the forces of nature, political unrest and accident or illness in remote regions without means of rapid evacuation or medical facilities. Also be aware and clearly understand that Argeus Tourism & Travel will not have liability regarding provision of medical care or the adequacy of any care that may be rendered. It is understood that Argeus Tourism & Travel uses their best efforts to ensure that all adequate measures are taken to avoid such occurrences. By signing the Tour Contract you are VOLUNTARILY PARTICIPATING IN THESE ACTIVITIES WITH THE KNOWLEDGE OF THE DANGERS INVOLVED AND HEREBY AGREE TO ACCEPT ANY RISKS. AS LAWFUL CONSIDERATION for the agreement with Argeus Tourism & Travel to participate in such trips and activities, you hereby agree that you will not make a claim against Argeus Tourism & Travel, and its employees from all claim actions and demands that you may have for bodily injury, death or property damage arising from your participation in a tour. Acceptance of the Tour Contract will serve as the release of Liability and Assumption of Risk agreement. This agreement is binding on your heirs, legal representatives, and assigns. If any portion is unenforceable, the remaining portions shall remain in full force and effect.
